She was the Marine Director of the Global Sustainable Fisheries Program at The Nature Conservancy (TNC), Director of TNC's Channel Islands Program, and lead successful island restoration and endangered species recovery. She spent three years at Earthwatch Institute in Boston and 10+ years in the eastern Caribbean leading conservation efforts and educational outreach campaigns to provide protection for endangered sea turtles and other at-risk marine species. Lotus is the Assistant Dean for Partnerships & Development for the Bren School of Environmental Science &

Management at UC Santa Barbara. Lotus has a Ph.D. in Marine Ecology from Dalhousie University, a MSc in Marine Resource and Environmental Management from the University of the West Indies, and a MSc and BSc in Behavioral Ecology and Primatology from McGill University.
